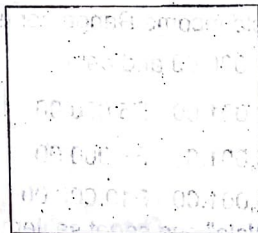
As such, I agree and authorize SLP to
